Cleaning service includes stripping of beds, laundry of all linens, and general house cleaning. Please leave the cottage as you found it.

Accommodations include; Dish TV - No Internet (no wifi) - No Local phone service- Waste Management. The end of the dock is in about 30 inches of water. You may secure your boat at our dock. Lake frontage is 100', please respect our neighbor's property. If you don't, you may get poison ivy!

Smoking is only allowed outside.

Dogs are allowed with owner's permission and additional pet deposit of \$100.00. Please do not use any of the bedding for your dog. **Removal of your dog's poop from the yard is mandatory!** Dog poop is bad for the lake environment and for all people, especially children.

Please report any maintenance problems immediately. Even the best appliances occasionally malfunction, and we cannot guarantee them to perform 100% of the time. We will attempt to correct all problems as soon as reasonably possible. There will be no discounts or refunds due to such problems.

We work very hard to ensure that our cottage is clean when you arrive. However, occasionally things are overlooked. Please, take a few moments to inspect the cottage on your arrival. The cottage is on a well and septic system. Do not pour grease down the drain. The water is very drinkable. The septic system is very effective; however, it will clog if improper material is flushed. DO NOT FLUSH anything other than toilet paper. No feminine products should be flushed at anytime. If it is found that feminine products have been flushed and clog the septic system, you could be charged damages of up to \$500.00.

There is a washer and dryer for housekeeping. In the summer, please start a load of towels before you leave, housekeeping will be there soon. It is extremely hard to get all of the bedding and towels done before our next guest arrive. If you remake the beds with clean bedding, please leave us a note.

All rooms have electric baseboard heaters. In the summer turn these off if you have used them during your stay and in the winter turn them down to 50. The heat pump will also go down to 50, you have to be very close to it with the remote and use the "economy" setting. The heat pump will also cool the air in the main part of the cottage. There are switches for a ERV system in the hallway. This system brings in conditioned fresh air. You can use this system in the winter and summer and it can run the entire time you are there. The upper switch is a "low" setting and the bottom is "high", these turn the system on.

This property is privately owned; the owners are not responsible for any accidents, injuries or illness that occurs while on the premises or its facilities. The Homeowners are not responsible for the loss of personal belongings or valuables of the guest. By accepting this reservation, it is agreed that all guest are expressly assuming the risk of any harm arising from their use of the premises or others whom they invite to use the premises. Refunds will not be made for said above conditions.

When departing please leave the cottage in the same order as your arrival. Upon departure, turn off lights (outdoor lights included) and appliances.
